## RULES AND REGULATIONS

### ADMISSION TO CLUB AND RECREATION AREA:

1. Limited to members in good standing and their guest(s).
2. The Log Book **MUST** be signed by all signatory members for guest(s) entering the Club building and grounds.
3. All guests and persons under the age of 18 **SHALL** be accompanied and supervised by a signatory member of the Club. (Written permission from member or parent is **NOT** acceptable).

### SWIMMING POOL:

1. Use the pool at your own risk. **(NO LIFEGUARD ON DUTY)**.
2. You **MUST** shower before entering the pool and after using suntan lotion or other body oils. **(HEALTH DEPT. RULES)**
3. Running, pushing or rough play in or around the pool is not allowed.
4. Toys and rocks are not allowed in the pool. Snorkels, goggles and life saving inflatables are the only items permitted in the pool.
5. Eating and/or drinking are forbidden in the pool.
6. All babies and toddlers **MUST** wear Health Dept. approved swim wear.

### CLUBHOUSE AND RECREATION AREA:

1. Wet swim wear is **NOT** allowed in the Clubhouse.
2. Shoes are required in the Clubhouse.
3. Equipment broken through negligence or carelessness, shall be replaced by the responsible member.
4. **POOL TABLE:**  
**Age requirements:** 18 years and older are considered adults. 14 years to 17 years are allowed to play when accompanied by and under adult supervision. **NO ONE UNDER THE AGE OF 14 YEARS CAN PLAY POOL.**  
**Time requirements:** Time limit of play is 30 minutes when others are waiting to play. Finish the game in progress. Good Sportsmanship rules apply.
5. Return all game equipment to the Clubhouse to insure availability to other Players. (Volleyball, shuffleboard, horse shoes, basketballs, etc.)

### GENERAL:

1. **ONLY** certified service dogs, allowed on the Club premises.
2. Plastic and paper containers **ONLY** are allowed on outside grounds.
3. All ABC rules will be followed. **NO ALCOHOLIC BEVERAGES TO BE BROUGHT ONTO THE CLUB PREMISES.**
4. Any member with 12 or more guests shall make arrangements to rent the Club and facilities.
5. Club member's key card **MUST** be kept in signatory member's possession at all times. (This is according to the Clear Lake Keys Club, Inc. By-Laws).
6. The Board of Directors, or any Club member in attendance, will use their authority to determine the qualifying ability of all persons using Club facilities. The Club member in attendance will enforce these rules without bias and shall ban persons not adhering to the rules.
7. In case of demise of Club member, the family will have use of Club facilities for Memorial Service at no cost.

### SMOKING:

1. No smoking anywhere in the Clubhouse at any time. Smoking is allowed out of doors only. Please dispose of the tobacco butts in the proper receptacles.
